2015 - 2016 RECOMMENDED PROGRAM

Based on discussion at the January 21 local program planning meeting, the Board recommends retaining the current Local Program.



1. **PARKS AND RECREATION PLANNING IN WASHINGTON COUNTY** with the focus being centered on the Marcellus Shale natural gas extraction in Washington County parks.

2. **STUDY OF WASHINGTON COUNTY'S ELECTION SYSTEM AND PROCEDURES** with the focus to survey agencies that are authorized or mandated to register voters in order to see how well the process is working. Possible areas to examine include: the training of agency workers to carry out the registration, the registration process itself, the transfer of registration forms to the county and/or state election departments, and the tabulation of citizens registered.

2015 League of Women Voters of PA State Convention June 5-7, 2015

The Convention, hosted by LWV of Greater Pittsburgh, will be held Friday, June 5, through Sunday, June 7, at the Hotel Monaco, a new boutique hotel in downtown Pittsburgh.

In 1915, the Pennsylvania Women's Suffrage Association began its first statewide political campaign, in support of Amendment 1, the Women's Suffrage Referendum. The Justice Bell, replica of the Liberty Bell engraved with "Establish Justice," its clapper chained and silenced, toured the state in the summer of 1915, accompanied by pennants and signs urging "Votes for Women!" On June 24, 1919, Pennsylvania became the 7th state to ratify the federal suffrage amendment. In 1920, the Suffrage Party changed its name to the League of Women Voters, the amendment became law, and the Justice Bell was brought in victory to Independence Mall, its clapper unchained. Our 2015 Convention will look back at the events of 1915.
